Research Summary:

25 Mill Street (Plat 24, Lot 230) is located in the Historic Hill District of Newport, Rhode Island. The building was constructed in 1885-1886 to house Newport's Steam Fire Engine Company No. 1.

Newport was founded in 1639 by religious dissidents who fled the Massachusetts Bay Colony to create a society where religion did not define government. Newport's first settlers agreed to support religious tolerance, or what they called "liberty of conscience". Newport's active seaport and promise of religious freedom drew a diverse population to the colonial city. By the mid-18th century, there were at least 10 different faiths coexisting with each other in Newport, and the port had become one of the five most prosperous in the colonies. During this period, the town experienced a building boom that included hundreds of houses and many internationally important landmarks that survive today. This prosperity was in large part due to Newport's diverse community, but also due to its strong participation in the trans-Atlantic slave trade.

Mill Street, originally called Carr's Lane, is one of Newport's earlier streets. It was named after Rhode Island Governor Caleb Carr (d. 1695), whose house stood west of present-day Trinity Church's Honyman Hall. The street ran down to Carr's wharf, where Carr operated a ferry service started in 1675. By 1777, the lower half of Carr's Lane, west of Spring Street, had become Mill Street, and the upper part, east of Spring Street, was called Banister's Lane.

The first known owner of the lot at-large was the Townsend family.² By 1876, the Townsends had divided the lot and William C. Townsend had a dwelling house on site at present-day 25 Mill Street. By 1883 the house had transferred to Charles Bateman, local Newport carpenter, who then sold the property in 1884 to the City of Newport. The City then removed the dwelling house to make way for the construction of a building to house Newport's newly created Steam Fire Engine Company No. 1. The brick building appears to have been constructed to replace a wooden building that housed an existing steam engine company known as Torrent No. 1 Engine Co., located across Mill Street just to the northeast. After the construction of the building for Steam Fire Engine Company No. 1, Torrent No. 1 does not show up in records. It is probable that, rather than disband entirely, Torrent No. 1 became Steam Fire Engine Co. No 1.

Torrent No. 1 was among one of Newport's oldest firefighting companies. The town of Newport experienced its first large scale fire in 1730 when a cooper's shop on Malbone's Wharf went up in flames and the fire quickly spread to neighboring structures. Shortly after, the town purchased its first fire engine, but by 1736 Godfrey Malbone decided Newport needed a newer model and presented the town with an engine known as 'Torrent No. 1' (*Cities in the Wilderness*, p. 370).

¹ A ferry service operated here, most recently as the Jamestown Ferry, until 1969 when the Newport Bridge was completed.

² Thomas and William C. Townsend, father and son, were proprietors of the Townsend Coffee House at the United States Hotel on Thames Street. William served in the Civil War, City Council and RI General Assembly and lived at the corner of Kay & Brinley.

In 1886, when the fire station at 25 Mill Street was constructed, the Newport Fire Department consisted of four steamer companies – Nos. 1, 2, 5, and 7; Hook & Ladder Company No. 1; and three hose companies – Nos. 4, 6, and 8. The new building for Steam Engine Company No. 1 included a driveway and a hot water system (*City Documents*: Annual Reports to the Mayor, 1886).

The building was used as a fire station until 1915 when it was sold by the City of Newport to Jeremiah Sullivan for private use. Steam Engine Co. No. 1 appears to have been disbanded that same year. The Annual Report of the Fire Department in 1914 lists five steam fire engine companies, and references ownership of 19 horses. The 1915 report makes no mention of the steam companies, only to say that steamers 5 & 6 would be held in reserve. The 1915 report also notes that all the department's horses had been sold (*City Documents*: Fire Department Annual Reports to the Mayor, 1914, 1915, Newport Historical Society). One can speculate that changes in technology eliminated the need for horse-drawn steam engine fire pumpers and therefore the steam engine companies of the fire department.

Property Details:

- The lot at-large is owned by the Townsend family, and the site of present-day 25 Mill Street appears to be vacant (1850 *City of Newport Map*).
- The Townsend lot has been subdivided. A dwelling house on it, owned by Wm. C. Townsend, is on site at present-day 25 Mill Street. Torrent No. 1 Engine Co. is located across the street (1876 Newport City Atlas).
- The lot for present-day 25 Mill Street has a dwelling house on it, owned by Charles Bateman. The size of the lot has increased. The address for the property is listed as 27 Mill Street (street numbers have changed over time). Torrent No. 1 Engine Co. is located across the street (1883 Newport City Atlas).
- Charles Bateman sells his property at 25 Mill Street to the City of Newport, 18 September 1884 (LE 55:23).
- Steam Fire Engine Company No. 1. is located in a new brick building at 27 Mill Street (now 25). Torrent No. 1 is no longer referenced.
- Fire Station No. 1 is shown at 27 Mill Street (present-day 25 Mill Street). The building for Torrent No. 1 Engine Co. (32 Mill Street) has been let go by the city and is under the ownership of Geo. Nason.
- The former bulding for Torrent No. 1 has been replaced. Steam Fire Engine No. 1 still operates from the station at 25 Mill Street (1907 Newport City Atlas).
- 25 Mill Street is sold by the City of Newport to Jeremiah Sullivan on 18 October 1915 (LE 101:65). Sullivan was a prominent city politician, city council member, bank officer, and land speculator.

- Jeremiah K. Sullivan dies, and the property transfers to Gertrude S. O'Connell, heir at law, 9 March 1939 (Tax Card).
- The property is deeded to Thomas M. Curry, 1 November 1943 (LE 154:8).
- Thomas M. Curry died, and the property is transferred by will to wife Marguerite Frances Curry, 17 April 1967 (Tax Card).
- 1968 The property is deeded to R.M. Richards, Inc. 25 October 1968 (LE 224:412).
- 1970 The property is deeded to Ted Materna Associates, Inc., 19 October 1970 (LE 230:496).
- The property is deeded to John and Ann Sherman; James Hyman and Arthur Murphy; John D. Sherman, 3 January 1979 (LE 288:250-253).
- 1983 The property is deeded to John Sherman and Jane Olson, 29 February 1983 (LE 311:856).
- The property is deeded to John Sherman; Steven McInnes, agent; Lucia Lawrence, 7 October 1987 (LE 402:95-99).
- 1990 The property is deeded to John Jed Pearsall, 20 September 1990 (LE 481:282).
- **2013** The property transfers to 25 Mill Street, LLC 23 April 2013 (LE 2348:149).
- 2022 25 Mill Street, LLC sells the property to Robert Weintraub, 14 January 2022 (LE 3062:307)

IMPROVEMENTS AND EXPENDITURES.

The usual supplies have been purchased and various improvements made for the use of the Fire Department during the year. Rubber coats have been furnished each company. Also fuel, oil, cleaning material and sundry repairs.

Steamer No. 1 has been furnished new wheels, and steamer and hose carriage painted and varnished.

The new Station on Mill street has been fitted up and is now occupied by the steamer company, the apparatus having been transferred from the old Station which was out of repair. A driveway has been provided in front of the building, and a system of hot water heating has been placed with boiler in the cellar.

The engine room at Station No. 2 has been kalsomined and wood work refinished with hard oil finish. A boiler house has been added and a steam boiler placed with pipes and connections for steam heating.

Curtains have been furnished for Station No. 4, also new fastenings for front doors.

Station No. 5 has been provided with a water-closet, the engine room cleaned, and ceiling and sash painted.
















The 1900 *Newport City Directory* lists Fredrick A. Gifford as the foreman of Steam Fire Engine Company No. 1. His residence is listed at 21 Mt. Vernon, and his occupation was carpenter.
